An ordinance for the levy and assessment of a tax for corporate purposes within the Village of Benson in the County of Woodford, State of Illinois, for the fiscal year May 1, 2018, to April 30, 2019.

BE IT ORDAINED BY THE BOARD of Trustees of the Village of Benson, Illinois:

SECTION I: That there be and there is hereby assessed for corporate purposes within the Village of Benson, Illinois, a body corporate in the County of Woodford, State of Illinois, for the fiscal year beginning May 1, 2018, to April 30, 2019, a sum of \$ 17,450.00 for general corporate purposes upon all property, subject to taxation within the said Village of Benson, Illinois, as the same is assessed and equalized for State and County purposes for the current year, and that said sum or tax be known as the tax for "corporate purposes," and be in addition to all other taxes, the several purposes for which said tax is levied or assessed for each purpose being shown by a copy of the Appropriation Ordinance of the Village of Benson, Illinois, for the fiscal year ending April 30, 2019, as approved by the Board of Trustees of the Village of Benson, Illinois, the said Appropriation Ordinance having been passed and approved on June 20, 2018, and published in accordance with the Statute therein made provided, which said Appropriation Ordinance as published is hereto attached marked "Exhibit A" and is expressly made part thereof as if copied herein.


SECTION II: That said tax so levied and assessed as aforesaid be collected and enforced in the same manner and by the same officer as the State and County taxes and be paid over by the Officer so collecting the same to the Treasurer of said Village of Benson, Illinois, as provided by law.

SECTION III: That the Clerk of the Village of Benson, forthwith make and file with the County Clerk of Woodford County, Illinois, a certified copy of this Ordinance.

SECTION IV: This Ordinance shall take effect and be enforced from and after passage and approval.






CERTIFICATE OF COMPLIANCE
